Leisure Services Committee update.

Following an inspection of the Pavilion earlier this week, the Acting Clerk was asked to arrange for a roofing contractor to look at the pavilion roof. In the meantime, the felt roofing has blown up in the wind and the window contractor has secured it whilst on site. The remaining work on the fascia and soffits is almost complete and the contractor has arranged for a small skip for removal of rubbish. A roofing contractor has been asked to look at the felt roofing.
