



# Notice of plant crossing, B4118 Birmingham Road, Water Orton

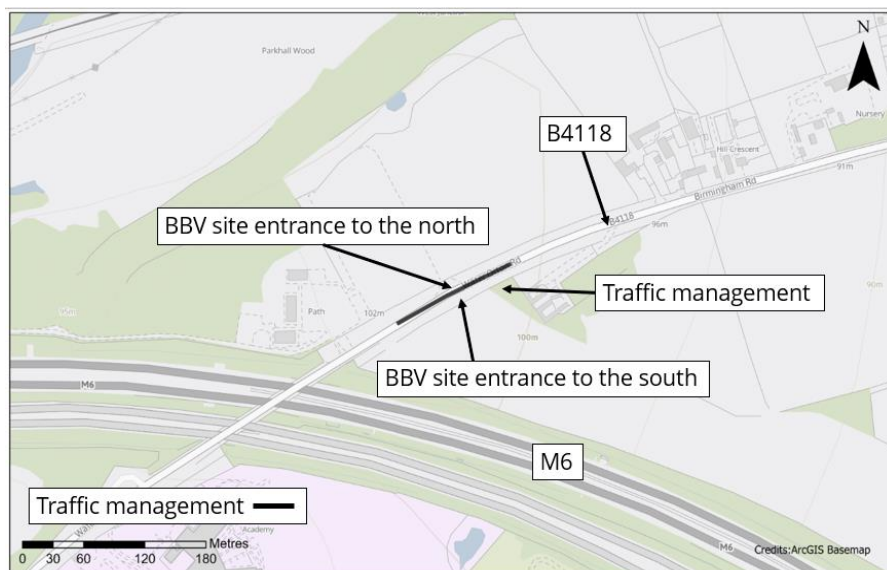
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

To continue to prepare for tunnelling works in the Water Orton area, we will install a crossing for plant over the B4118 Birmingham Road. This will allow safe crossing for plant and work vehicles from our sites to the north and south of B4118 Birmingham Road.

## Traffic management

In order for the plant crossing to be safe when in operation, a four-way traffic light system will be installed on the B4118 Birmingham Road. This will manage traffic from either direction along the B4118 and the two entrances to our sites on the north and south of the road. The lights will be in place 24 hours a day but will only be in use when required. We will try to limit the cross movements to off peak hours as much as possible. The traffic lights will be manually controlled throughout, and priority of the traffic management will always be given to B4118 Birmingham Road to ensure traffic flow is impacted as least as possible.



## Duration of works

Plant crossing to be operational on B4118 Birmingham Road from Tuesday 20 June 2023 until December 2025 between 7am and 7pm to begin with.

## What to expect

Four-way traffic light system to be in place along B4118 Birmingham Road and within BBV site entrances

Traffic lights to be in place 24 hours a day but only used when required

Priority of the traffic lights to be given to B4118 Birmingham Road

Traffic lights to be manually controlled throughout use
